Opinion

1. In our opinion and to the best of our information and according to the explanations given to us, except for any effect to the matter described in other matters paragraph, the Project Financial Statements (collectively referred as "the Statements") give true and fair view of the financial position of the Project as at and for the year ended March 31, 2021, in accordance with Note 3 of the Statements. Also in our opinion, the Management of PMU, NDSP ("the Management") has maintained, in all material respects, accounting and internal controls over financial reporting of the PMU and the PMU's accounting and internal controls over the financial information submitted by the EIA's selected by us and such accounting and internal controls were operating effectively as of March 31, 2021 based on the criteria described in paragraphs 9.4 and 9.5 of the Project Implementing Plan.

We have audited the accompanying Special Purpose Project Financial Statements of National Dairy Support Project (NDSP), financed by International Development Association (IDA) under Credit/Loan no. IN-5074 and implemented by National Dairy Development Board. These financial statements comprise the Statement of Sources and Application of Funds, related Significant Accounting Policies and the accompanying related notes as at and for the year ended March 31, 2021. In accordance with Contract No. PMU/Cons-F/025 dated May 02, 2017 ("the contract") entered with Project Management Unit ("PMU") and its first amendment to the contract dated March 15, 2018 ("the Contract"), the second amendment to the contract is made on March 6, 2019, third amendment to the contract is made on January 06, 2020, and fourth amendment to the contract is made on September 10, 2020. We also have audited the accounting and internal controls of the PMU (as described and set out in the paragraphs 9.4 and 9.5 of the Project Implementation Plan, dated March 23, 2012, issued by the World Bank) and the accounting and internal controls of the PMU over the financial information submitted by the End Implementing Agencies (EIAs). The Statements have been prepared by the Management of NDSP's PMU in accordance with the basis of accounting and preparation set out in Note 3 to the accompanying Statements to comply with the Contract.

Basis for Opinion

2. We conducted our audit in accordance with the Standards on Auditing issued by Institute of Chartered Accountants of India (ICAI). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Statements* section of our report. We are independent of the implementing agency in accordance with the ICAI's Code of Ethics for undertaking this assignment, and we have fulfilled our ethical responsibilities in accordance with ICAI's Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.



Emphasis of Matter

3. Without modifying our opinion, we draw attention to note 3 of the Statement, which describes the Basis of Accounting. The PFS is prepared to assist the National Dairy Development Board to meet the financial reporting requirements of the Project/Financing Agreements for Investment Project Financing dated April 13, 2012 in respect of preparation Project Financial Statement in a manner to reflect the operation, resources and expenditures related to the project. As a result, it may not be suitable for any other purpose.

Management's Responsibility for the Statements

4. Management is responsible for the preparation of the Statements in accordance with the basis of preparation set out in Note 3 to the Statements that give a true and fair view of the Statements, laying down and maintaining effective accounting and internal controls in accordance with requirements of paragraphs 9.4 and 9.5 of the Project Implementing Plan. This responsibility include the design, implementation and maintenance of adequate accounting and internal controls that were operating effectively for ensuring the accuracy and completeness of the accounting records relevant to the preparation and presentation of the Statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

The Management and those charged with governance are responsible for overseeing the implementing agency's financial reporting process.

Auditor's Responsibility

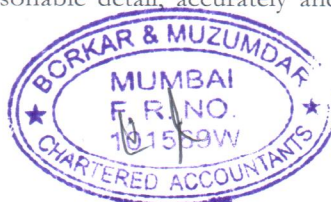
5. Our responsibility is to express an opinion on the Statement and an opinion on the accounting and internal controls of the PMU, the accounting and internal controls of the PMU over the financial information submitted by such EIAs as aggregated in PMU/Cons-F/025. We conducted our audit in accordance with the Standards on Auditing issued by Institute of Chartered Accountants of India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the Statements subject to the expenditure covered in Note 3.1 column (b) and (c) are free of material misstatements and whether effective accounting and internal controls was maintained in accordance with paragraphs 9.4 and 9.5 of the Project Implementation Plan.

An audit involves performing procedures to obtain evidence about the amounts and the disclosures in the Statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the Statements, whether due to fraud or error. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the accounting estimates made by the Management, as well as evaluating the overall presentation of the Statements. Our audit of accounting and internal controls included obtaining an understanding of the accounting and internal controls assessing the risk that a material weakness exists, and testing and evaluating the design and operating effectiveness of the accounting and internal controls based on the assessed risk. Our audit also included performing such other procedures as we considered necessary in the circumstances.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinions.

The PMU's accounting internal controls is a process designed to provide reasonable assurance regarding the reliability of financial reporting and the preparation of the Statements for the external purpose in accordance with the basis of preparation set out in Note 3 to the accompanying Statements. The Project's accounting and internal control over financial reporting includes those policies and procedures that:

- (1) pertains to the maintenance of records that, in reasonable detail, accurately and fairly reflect the transactions and dispositions of the assets of the Statements;



- (2) provide reasonable assurance that transactions are recorded as necessary to permit preparation of statements in accordance with basis of preparation set out in Note 3 to the accompanying Statements, and that receipts and expenditures are being made only in accordance with basis of preparation set out in accordance with authorization of Management of PMU, NDSP and
- (3) provide reasonable assurance regarding prevention or timely detection of unauthorized acquisition, use, or disposition of the PMU's assets that could have a material effect on the Statements.

Because of the inherent limitation of Accounting and Internal Controls, including the possibility of collusion or improper management override of controls, material misstatements due to error or fraud may occur and may not be detected. Also, projections of any evaluation of the accounting and internal controls over financial reporting to future periods are subject to the risk that the accounting and internal controls over financial reporting may become inadequate because of changes in conditions, or that the degree of compliance with the policies or procedures may deteriorate.

Other Reporting Matters pursuant to the Contract

6. In accordance with the terms of the contract, we report that to the best of our knowledge and belief, and according to the information and explanations given to us:
- (a) In our opinion, proper books of accounts as required under the Project Implementation Plan are kept by the management so far as it appears from our examination of these books;
 - (b) The Statements dealt by this Report are in agreement with the books of accounts maintained at PMU by the management;
 - (c) The Statements have been prepared as per the Contract read along with the basis of accounting and preparation paragraph;
 - (d) The project funds are utilized for the purposes for which they were intended;
 - (e) the expenditure shown in the Statement are eligible for financing under the legal agreement as referred in the Contract, are recorded in the books of account of the Project and no other sources of Funds have been received by the management for incurring these expenditure;
 - (f) As more fully described in paragraph 4, the Management of PMU, NDSP has maintained, in all material respects, accounting and internal controls over financial reporting of the PMU and the PMU's accounting and internal controls over the financial information submitted by the EIAs and such accounting and internal controls were operating effectively as of March 31, 2021.

Restriction on Use

7. Our report is intended solely for the purpose of compliance with the Contract referred to above and should not be used for any other purpose.

Notes Forming Part of Project Financial Statements

1. National Dairy Support Project (“NDSP or the Project”) / National Dairy Plan Phase I (“NDP-I”) is a Central Sector Scheme was implemented through a line of credit from International Development Association (“IDA”) for a period of eight years from Financial Year 2011-12 to 2018-19 with an objective to help increase the productivity of milch animals and thereby increase the milk production to meet the rapidly growing demand of milk and to help provide rural milk producers with greater access to organised milk processing sector in project areas in India.

The Project closing date as per financing agreement between Government of India and International Development Association was extended till 29 November 2019. There was a grace period of four months for submission of claims to the World Bank and the financial closure of NDP I has been done as at 31 March 2020 with the World Bank.

The total outlay of the Plan is ₹22,420 Million comprising of ₹15,840 Million as International Development Association (IDA) credit, ₹1,760 Million as Government of India share ₹2,820 Million as share of End Implementing Agencies (EIAs) and ₹2,000 Million by National Dairy Development Board (NDDDB) and its subsidiaries by way of technical and implementation support. The Project was being implemented by the Project Management Unit (“PMU”) in NDDDB through EIAs.

2. The funds for the project flew from the budget of Department of Animal Husbandry & Dairying (DAHD), Ministry of Fisheries, Animal Husbandry & Dairying, Government of India (GOI) to the PMU in NDDDB as grant-in-aid for onward distribution to the EIAs. A separate bank account for receipt of funds and also separate project accounts are being maintained for NDSP/NDP-I as stipulated in the administrative approval issued by the GOI. No funds were received from DAHD, GoI during financial year 2020-21.

3. **Basis of Accounting and Preparation:**

The policies mentioned hereunder are adopted in the preparation of Sources and Application of Funds Statement (the “Statement”).

- 3.1 The Project Financial Statements have been prepared by PMU in accordance with the provisions of the Contract No. PMU/Cons-F/025 dated 02 May, 2017 and its first amendment to the contract dated March 15, 2018 (“the Contract”), with the second, third and fourth amendments to the contract made on March 6, 2019, January 6, 2020 and September 10, 2020 respectively.

The NDP - I, being a central Government project, accounts are maintained on cash receipts and disbursement basis, under Historical Cost convention and generally accepted accounting practices and standards in India. On this basis funds received from GOI and other receipts are recognised when received rather than when earned, and application of funds are recognised when the amount is spent by End Implementing Agencies or PMU in reporting period and such expenditure is approved by PMU till the time of submission of Interim Unaudited Financial Reports to the Government of India, rather than when the obligation is incurred.

No claims were submitted to the World Bank during the year 2020-21 as the World Bank has disbursed the full amount by the year 2019-20 as per Financing Agreement. Hence ‘Statement of Withdrawal applications submitted by the Project Management Unit for the year 2020-21’ and ‘Reconciliation of claims to total application of funds for the year 2020-21’ have not been prepared.

After financial closure of NDP I accounts, GFR 12-A will be submitted to Government of India.

- 3.6 A scientifically planned multi-state initiative on genetic improvement program was launched under National Dairy Plan I (NDP I) to increase the milk production by increasing productivity of milch animals in existing herds through a focused and systematic process of feeding and breeding. Under Progeny Testing, Pedigree Selection and Bull Production through Transfer of Imported Embryos sub-projects, High Genetic Merit (HGM) bull calves have been produced and they were allocated to different semen stations at a rate fixed by expert committee, constituted by DAHD, GOI.
- It has been decided to maintain the corpus funds, generated out of sale of bull calves to semen stations, in a central corpus fund account at NDDB. The corpus fund of Rs. 405.61 million (including Rs. 0.22 million to be received) would be utilised for various activities approved by National Steering Committee (NSC).
4. The expenditure reported in the Project Financial Statement are based on the Project books of account and the Fund Utilization Certificates/requests received from various EIAs and approved and accounted by PMU.
5. We have received refunds of Rs 17.27 million as on 31 May 2021 out of Rs. 17.58 million receivable on 31 March 2021 from the EIAs.
6. The **Independent Evaluation Group (IEG)** of the World Bank has concurred with outcome rating of "Highly Satisfactory" for implementation of National Dairy Plan Phase I assigned by the **Implementation Completion and Results Report (ICRR)** of the World Bank.
7. The figures of the previous year have been regrouped wherever necessary.
